



## SCHOLARSHIP PROGRAM

The purpose of the IREM Northern Nevada/Tahoe Chapter 89 Educational Scholarship Fund is to provide financial assistance to an individual interested in furthering his or her education in the field of real estate. The recipient will be awarded a Scholarship of \$500.00 to be applied towards Classic Member Rate course tuition and books, travel and/or lodging whether in a traditional classroom or online setting. Scholarships awarded will be available for use through the end of the calendar year in which the funds were awarded.

### Selection Criteria:

To be considered for this award, the following requirements apply and are used in the process of selecting recipients:

1. Applicant demonstrates interest in the practice of real estate management and has at least one year of experience in the industry.
2. Applicant must attend at least three chapter general meetings/events each year.
3. Applicants' past involvement with the chapter may be considered.
4. Applicants must submit this application along with their resume and a letter of recommendation.

### Deadline:

Application deadline will be the last day of each quarter per the calendar year (March 31, June 30, September 30 and December 31). Scholarships will be awarded once per quarter and winners will be notified and announced within two weeks of the end of the quarter to make funds available for reimbursement at the earliest convenience.

### Use of Scholarship:

Scholarships must be used for education courses offered through the end of the calendar year in which funds were awarded. Any awarded funds not used within the calendar year will be lost. Applicants must re-apply each quarter to be considered for a new scholarship. Scholarship funds will be in the form of a reimbursement to the individual. Applicants must provide receipt that they have enrolled in a course in order to be reimbursed the funds. Scholarship funds may be utilized towards course and materials, travel and lodging but reimbursement funds will not exceed the amount awarded as defined above.
